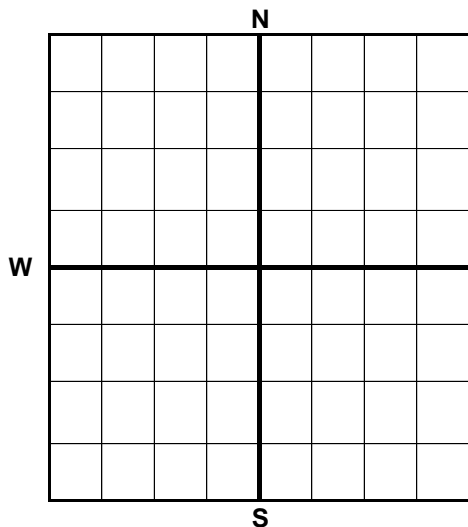

Construction requirements for flow back water pits exceeding 50,000 bbls.

Special construction requirements are found under 165:10-7-16 (f)(2).

The Manager of Field Operations will approve the application for pits that fall under this section. Phone no. 405-521-2240.

1. Operator must provide contact person responsible for management and operation of the pit.
2. A detailed drawing of the pit with complete construction plans drawn to scale by or under the supervision of a registered professional engineer. The capacity of pit is measured with three (3) feet of freeboard.
3. Liner must be minimum thickness of 30 ml, chemically compatible with fluids stored in the pit and ultraviolet light protection guaranteed for the time the pit is to remain in use. Approval of final construction must be accompanied by a written certification from the installer that the liner was installed according to commission rules.
4. Written permission of the surface owner.
5. Sampling of monitor wells / leachate collection system shall occur prior to accepting any fluids. The appropriate field inspector shall be notified at least 24 hours in advance of commencement of operations in order to witness and/or split samples.
6. Special engineering requirements will require written explanation as to the reason for the requested modifications along with schematics detailing the modifications.
7. Surety for the pit must be filed with the Manager of Document Handling prior to approval of the permit. Security requirements are found in 165:10-7-16(f)(9).
8. Operation of the pit will not commence prior to inspection by the Conservation Division.
